Clinical Pharmacy Specialist – Antimicrobial Stewardship & Infectious Diseases

The National Institutes of Health (NIH) Clinical Center (CC) Pharmacy is seeking a highly motivated clinical pharmacy specialist to provide pharmaceutical care to patients participating in NIH protocols in a federal research hospital. The NIH CC Pharmacy Department strives to exceed the expectations of patients, investigators, and co workers in an environment that provides the pharmacy staff with motivation, challenge, and professional growth.

The successful candidate will be an exceptionally talented, knowledgeable, and motivated Clinical Pharmacist with extensive experience providing pharmaceutical care to patients with a variety of infectious diseases. The Clinical Pharmacist must demonstrate a mastery of providing patient care and understand research methodologies, protocol design, and implementation. A Doctor of Pharmacy degree, post-graduate year 1 and year 2 residency training, and board certification (BCPS with Added Qualifications in Infectious Diseases), are highly desired for this position.

This position is located in the Clinical Pharmacy Specialist Section of the Pharmacy Department, Clinical Center (CC). The successful candidate will have a strong background in antimicrobial stewardship by promoting the optimal use of antimicrobial agents, providing advice on how to reduce the transmission of infections, and provide education regarding optimal antimicrobial use. He/she will be responsible for antimicrobial stewardship for patients across all Institutes and work closely with the Hospital Epidemiology Service. The pharmacist will also provide support to the Infectious Disease Clinical Pharmacy Specialist.

The Pharmacy Department strives to exceed the expectations of patients, investigators, and co-workers in an environment that provides the pharmacy staff with motivation, challenge, and professional growth.

The selected candidate will join a multidisciplinary team practicing in an environment of progressive, integrated, pharmaceutical services. Opportunities for pharmacy-based research, teaching and publishing are available. The Pharmacy Department offers state-of-the-art services in an ultra-modern facility and supports tuition assistance and clinical training for advanced degrees. The NIH Clinical Research Center is located on a 300-acre college-like campus and is the hospital where the intramural research of the NIH's 27 Institutes and Centers is conducted.

Applicants must be licensed to practice pharmacy in a State, territory of the U.S., or the District of Columbia and meet the minimum educational requirements required for the position. Benefits associated with federal employment are included. The salary ranges from \$104,796 to \$126,729 and will be commensurate with experience and present salary.
