Learning Objectives

What happened to HCAP? Approaches to Appropriate Therapy for Pneumonia Originating from the Community.

Proposed Speaker: Karl Madaras-Kelly, PharmD, MPH

Objectives:

1. Review the history of healthcare associated pneumonia (HCAP) as a definition and the implications on use of broad-spectrum antibiotics in the United States
2. Discuss recent literature contradicting the utility of the HCAP definition as a predictor of multidrug resistant organisms in patients presenting to the hospital with pneumonia
3. Outline alternative strategies to selection of empiric therapy in pneumonia based on pathogen-specific risk factors and the impact these may have on broad-spectrum antibiotic use

4. Discuss the implications of fluoroquinolone and cephalosporin resistance on use of other antibiotics and the implications of squeezing the balloon
